Multiplier events

The series of meetings with representatives of the companies took place during Multiplier events. The objective of the promotional workshops was to disseminate information about the project, get in contact with main stakeholders from the region and consult the course content. An integral part was also collecting feedback and encouraging the participants to get involved in the project activities.

Multiplier events in Slovenia, Czech Republic and Romania

The series of Multiplier events started in **Slovenia** on May 30th, 2023. The seminar was organized as “Education for Sustainable Business Reporting under the new European Guideline”. Overall, the proposed course was very well received, and companies were interested to learn more and to participate in the course. After the presentation, there was a discussion on many topics and suggestions were collected from the participants.



The second of the Multiplier event series took place in Prague, **Czech Republic** on October 24th, 2023, organized by the project partner ENVIROS. It was attended by representatives of public and business sector. The participants were introduced to the SECuRe project and its goals and invited to participate in the following programme being prepared in the form of a Pilot course.

The primary goal of the multiplier event organised in Timisoara, **Romania** on November 15th, 2023 was to disseminate and multiply the knowledge, innovations, or outcomes generated by the SECuRe Erasmus+ project to a wider audience, to share information about the project objectives, the partners, implemented activities and results obtained so far. 22 people accepted the invitation. Several topics were discussed, such as the ESG framework and requirements of the new European directives related to sustainability management and reporting.



Multiplier events in Spain and Poland

The Multiplier Event in **Poland** took place on the 30th of January, 2024, at the Modern Technology Centre in Gliwice, with the participation of 19 persons. The form of the event was hybrid: on site and online. The event consisted of a 4-hour seminar, during which the opportunity was taken to conduct a small demonstration of the innovative SECuRE educational technology produced within the project. Subsequently, it was discussed the ESG framework, including requirements of the new European directives related to sustainability management and reporting. The Multiplier event provided opportunities for networking and collaboration. Participants could share their experience, discuss potential collaboration, and establish new connections.



The Multiplier Event in **Spain** took place on February 27th 2024 in Arrasate/Mondragón, with 21 participants. The seminar had an in-person format. It consisted of a 4-hour lecture, where the aim was to inform the attendees about the project and its general and specific objectives and show them the development of the project content, a demonstration of all the tools developed in it and the training module. There was further discussion on many topics. The feedback was satisfactory, and the importance of the topic and its proper format (e-learning) was highlighted.



Experimental online course

At the beginning of April 2024, an experimental course will be launched. It will be possible to study online ESG topics in 6 blocks for one month. During the course, users will gain both broad knowledge of ESG and sustainability topics, but also learn a lot of practical information about sustainable reporting, which has become mandatory for many companies.
